AGREEMENT WITH THE PROSECUTOR'S OFFICE AT THE COURT OF FIRST INSTANCE OF THE GENERAL JURISDICTION OF ELBASAN



The Directorate of Free Legal Aid, represented by the Director of the Directorate for the Implementation and Administration of Primary Legal Aid, Mrs. Patricia Pogace, and Mrs. Suela Qevani, Head of the Primary Legal Aid Service Providers Management Sector, has entered into an agreement with the Prosecutor's Office at the Court of First Instance of the General Jurisdiction of Elbasan regarding the provision, free of charge, of premises for the operation of the Primary Legal Aid Service Center in Elbasan.

The Directorate of Free Legal Aid, referring to the Cooperation Agreements signed with 13 law faculties, has conducted training on Free Legal Aid for 293 students. During the training, students were informed about primary and secondary legal aid, as well as the role of Law Clinics in providing Free Legal Aid services. The participating students were welcomed to engage in a 3month work practice at the Directorate of Free Legal Aid and the Primary Legal Aid Service Centers. Upon completion of the practice, the engaged students will be issued a certificate by the Minister of Justice.

The process of signing service contracts with 140 lawyers, part of the list of Secondary Legal Aid providers, has been completed. Free legal representation is ensured through all local bar associations in Albania.
