The focus of these meetings was to establish bridges of cooperation between the Directorate and small municipalities, in order to ensure equal access to justice for every citizen.

The Directorate of Free Legal Aid conducted a training session with representatives of non-profit organizations that receive funding from the state budget to provide primary legal aid services.

THE COOPERATION AGREEMENT WAS SIGNED BETWEEN THE DIRECTORATE OF FREE LEGAL AID AND THE GENDER ALLIANCE FOR DEVELOPMENT CENTER.

The agreement signed between the Directorate of Free Legal Aid and the Gender Alliance for Development Center establishes cooperation in the provision of free legal aid services, with the aim of taking measures to enhance access to justice for vulnerable groups, with a particular focus on the protection of labor rights.


